

WAIVER AND RELEASE OF LIABILITY

(Read Carefully)

In Consideration of Legends System furnishing services and /or equipment to enable me to participate in Legends System games, I agree as follows:

I, the undersigned, understand that the Legends System has taken precautions to provide proper equipment and qualified instructors, but it is impossible to guarantee absolute safety. Participants must realize that there is a degree of risk and personal responsibility for safety when you participate in adventure activities. Since the events are mainly conducted in wilderness areas, injuries can occur and some activities may be stressful and physically hazardous. I assume all risks incidental to my use of the site and activity, including bruises and other more serious injuries. Further, since I may also be participating in mock battles using padded weapons, there is a risk of injury from other participants. I am participating voluntarily and choosing to take part in the activities on my own free will.

I, fully understand and acknowledge that: (a) risks and danger exist in my use of the Legends System equipment and my participation in Legends System activities: (b) my participation in such activities and/or use of such equipment may result in my injury or illness, including, but not limited to, bodily injury, disease strains, fractures, partial and/or total paralysis, eye injury, blindness, heat stroke, heart attack, death or other ailments that could cause serious disability: (c) these risks and dangers may be caused by the negligence of the owners, employees, officers or agents of Legends System, the negligence of the participants, the negligence of others, accidents, breeches of contract, the forces of nature or other causes, these risks and dangers may arise from the foreseeable and unforeseeable causes, and (d) my participation in these activities and / or use of equipment, I hereby assume all risks and dangers and all responsibility for any losses and / or damages, whether caused in whole or in part by the negligence or other conduct of the owners, agents, officers, employees or Legends System or by any other person.

I understand the risks involved in participating in the events sponsored by Legends Systems, I shall make no claim of any description against the organization, members or officers of the Legends System or any company doing business with the organization for any loss or damages suffered in the course of participating. I agree to act with good judgment.

I confirm that I am in good physical health and do not suffer from any physical disabilities unknown to Legends System. I agree also to the following restrictions placed upon me by Legends System:

- ** I will not use the padded weapons approved by Legends System unless I have first been instructed in their proper use through safety training;
 - ** I will not bring or consume alcoholic beverages or any illegal drug during any Legends System event; Anyone caught will be immediately dismissed from the site/ property.
 - ** I will not use any skills taught by Legends System for illegal purposes;
 - ** Unless I submit a written and signed request stating the opposite, I will allow Legends System to photograph, film or videotape me participating in Legends System events and to use the film or tape in it's books, fliers, and publicity materials;
 - ** I will not charge admission to any event I may hold using the rules of Legends System,
- Nor will I claim to be a subsidiary or representative of Legends System;
- ** I will at all times abide by the safety rules of Legends System.

I understand that failure to abide by these agreements could result in expulsion from Legends System or in the extreme, legal action.

I, on behalf of myself, my personal representatives and my heirs, hereby voluntarily agree to release, waive, discharge, hold harmless, defend and indemnify Legends System and it's owner agents, officers, employees from any and all claims, actions, or losses for bodily injury, property damage, wrongful death, loss of service or otherwise which may arise out of my participation in Legends System activities. I especially understand that I am releasing, discharging and waiving any claims or actions that I have presently or in the future for negligent acts or other conduct by owners, agents, officers or employees of Legends System.

By my signature, I confirm that I have read this release, understand it's terms, and agree to it's provisions.
I understand that this form affects my legal rights.

Legends System does not provide insurance for the minor's person or property.

I HAVE READ THE ABOVE WAIVER AND RELEASE AND BY SIGNING IT AGREE IT IS MY INTENTION TO EXEMPT AND RELIEVE Legends SYSTEM FROM LIABILITY FOR PERSONAL INJURY, PROPERTY DAMAGE OR WRONGFUL DEATH CAUSED BY NEGLIGENCE OR ANY OTHER CAUSE.
